1	Welcome by the Parish Council Chairman Cllr Kerri Kitto welcomed everyone to the Annual Parish Meeting.	
2	Apologies Apologies had been received from Cllr Sam Burton and Cllr Geoff Gale.	
3	Minutes of the last meeting. It was resolved that the minutes of the Annual Parish Meeting held on Tuesday, 2 May 2023 be adopted and signed as a true and accurate record. Cllr Kerri Kitto then signed the minutes.	
4	Cornwall Councillor's Report Cllr Dominic Fairman shared his admiration for everything that St Teath achieves as a parish and said he felt there was exemplary activity from the Parish Council helping to make St Teath a model village in the way it works as a community, for the community and in the community.	
5	Questions/Recommendations from residents A member of the public queried how the new traffic calming activity was working. Cllr Kerri Kitto explained that a second VAS camera is due to be installed in the coming week. The PC will then move the two cameras around the village periodically. The access from Trehannick Road on to the A39 was also queried and the Parish Clerk advised that all highways issues needed to be referred to Cornwall Council as it was out of the Parish Council's jurisdiction. Several parishioners also wished to thank the Parish Council for all their hard work and commitment to the village over the past year.	
6	Presentations by local community groups and organisations Seven groups were represented at the meeting with everyone having the opportunity to share their news and plans for the year ahead. Several groups requested the need for more volunteers and there were lots of sharing ideas and support between the groups.	

7	<p>Community Sparks Fund 2025 Cllr Kerri Kitto explained that £6970 had been granted in this year’s Community Sparks Fund and then outlined the timeframe for submitting a bid request for funding from the 2025 Community Sparks Fund. The fund will continue to run annually and the deadline for submissions for this year will be 30 September 2024 with successful funds being awarded in January 2025 for use in that year. The Parish Clerk will provide all groups with details of how to apply for the 2025 funding over the coming weeks</p>
